

## WEST PIERCE FIRE & RESCUE PIERCE COUNTY SHARED PURCHASING GROUP LETTER OF INTENT TO PARTICIPATE

This letter is affirmation of Pierce County Fire District 3's (West Pierce Fire & Rescue) intent to participate in the Pierce County Shared Purchasing Group's (PCSPG) cooperative vendor bid process for EMS Medical and Pharmaceutical Supplies. It is our understanding that the PCSPG cooperative currently includes; West Pierce Fire & Rescue, East Pierce Fire and Rescue, Central Pierce Fire and Rescue, Orting Valley Fire and Rescue, and the Graham Fire Department.
