Safe Sitter Classes Resume in August!



students with life-long skills and create future generations of safety-conscious adults and parents

For years, adolescent babysitters have been "stepping in" for parents who are "stepping out." While many of these young people bring a desire to care for children, few are prepared for the magnitude of responsibilities they assume. East Pierce Fire teaches the Safe Sitter curriculum to help equip students with life-long skills and create future generations of safety-conscious adults and parents.

Safe Sitter is a medically-accurate program that teaches boys and girls in grades 6-8 how to handle emergencies when caring for children. The three-day class includes safe and nurturing childcare techniques, behavior management skills, and appropriate responses to medical emergencies. In addition to fire and injury prevention, it also teaches business skills for running a babysitting business.

HAAS ALERT SYSTEM: Preventing Collisions with Digital Alerts

raveling to and from the scene I of an emergency call is more dangerous for emergency responders than ever before. In a world where drivers are dealing with multiple

distractions, and sirens and lights can go unseen and unheard, East Pierce Fire and Rescue is looking for ways to improve firefighter and public safety

while our apparatus is on the road responding to emergencies. That's where Safety Cloud's HAAS Alert System comes in.

HAAS Alert System is a cloud-based collision avoidance technology that sends real-time alerts to a motorist's mobile or navigation device in the vicinity of an emergency vehicle

that is en-route or positioned at the scene. Using the HAAS Alert, motorists on the road will be alerted to the incoming presence of an emergency response vehicle. Chrys-


> ler, Dodge, Jeep, Ram, and Alfa Romeo, equipped with Uconnect, are the first automobiles capable of receiving these safety alerts directly on the vehicle's infotainment

screen. HAAS Alert expects additional connected vehicles to receive these alerts later this year.

"East Pierce Fire & Rescue is evaluating the HAAS Alert System for one-year on our fleet of nine fire engines and a ladder truck," said Assistant Chief Jeff Moore. "We hope the implementation of this new

technology will enhance situational awareness for all motorists on the road and help keep both firefighters and civilians safer by avoiding collisions."

In addition, drivers using Waze and Apple Maps will also receive alerts through Safety Cloud's integration with those platforms.



When responders activate apparatus emergency lights, approaching drivers receive real-time digital alerts to slow down and move over. These are delivered via apps, navigation systems, or mobile devices to drivers up to 30 seconds in advance and reduce the risk of collision by up to 90%.

BOND UPDATE: Steady Progress

In November 2018, voters approved a bond to replace all six front-line fire engines, a ladder truck, replace four fire stations, and build a new fire station in Tehaleh. All apparatus have now been received and placed into service throughout the fire district.

The fire station construction projects slowed due to COVID impacts but are once again moving along. Below is a status update of these projects.

FIRE STATION CONSTRUCTION STATUS

- Station 118/Edgewood: Under construction with estimated completion in late fall 2022.
- Station 111/Bonney Lake: Construction to begin late summer 2022.
- Station 114/Lake Tapps: Construction to begin early fall 2022.
- Station 117/Tehaleh: Construction to begin late fall 2022.

• Station 112/Prairie Ridge: Construction to begin spring 2023.


Architectural rendering of the new Station 118.

Meet the NEW Marine 122

Have you seen firefighters training recently with EPFRs new rescue boat on Lake Tapps? Crews will continue to rotate through training the rest of this month and hope to have the new boat serving our communities by mid-July.



The new rescue boat will replace our nearly 30-year-old pontoon-style boat that has served well but is overdue for surplus.

The old Marine 122 was built and designed from a recreational shell that is now failing with dry rotted wood decking, an outdated motor,

an insufficient fire pump, and old technology and electronics.

The new Munson boat is all aluminum and has superior response and maneuvering capabilities and increased water supply abilities for places around Lake Tapps with limited fire hydrants.

HEALTH Answering Your Questions About Ambulance Fees



Why did we receive a bill for ambulance service? I thought East Pierce Fire and Rescue residents receive free ambulance service from the fire district?

East Pierce ambulance service is not actually • free. However, if you are an East Pierce resident, who is transported by an East Pierce medic unit (ambulance), you should have no "out-of-pocket" expenses. We bill your insurance company, Medicare or Medicaid for the cost of the ambulance ride. Any additional costs, such as co-pays that you would normally need to pay will be "written off" against the funds received through our EMS Levy. Some residents will receive a copy of the ambulance billing statement, indicating the cost of the service provided, and stating that this is NOT a bill which requires payment. Instead, this statement is provided to you along with a request that you provide additional information so we can bill your health insurance provider(s).

What happens for people who have no insurance or those who live outside the fire district?

If you're a district resident and don't have • health insurance, your entire bill is covered by the EMS levy. Non-residents, who happen to be in the district when they are transported by medic unit to the hospital, are responsible for

co-pays or any portion of the ambulance bill not covered by their insurance.

Does East Pierce Fire and Rescue attempt to bill our insurance companies?

Yes. EPFR will bill your insurance company, Medicare and Medicaid providers to recover payments for ambulance transport. To be included in the "no out-ofpocket" cost EMS transport program, residents must complete and return any required paperwork sent to you by our billing service, Systems Design, or any paperwork sent to you by your own insurance provider. Correct, updated information is crucial for our ability to successfully bill insurance provid-

If district residents don't comply with requests for information, they could end up being liable for the entire amount of the ambulance transport fee, and even end up being turned over to a collection agency.

What happens to the revenues collected • from medic unit patient transport fees?

More than \$2.8 million in ambulance trans-• port fees are collected each year from health insurance companies, Medicare and Medicaid. These funds help cover a portion of the cost of providing EMS response and ambulance transport services to the community.

What happens if East Pierce doesn't have any medic units available for a 9-1-1 medical call? Who comes, and do I have to pay the other ambulance provider?

East Pierce has four medic units available • 24/7. We handle more than 98% of the EMS ambulance transports with our own medic units. Last year we transported more than 6,000 patients to area hospitals.

However, when all of our medic units are busy on other 9-1-1 medical or fire calls, we need to request "mutual aid" from neighboring fire departments and private ambulances. They send units in to back us up if we don't have any available medic

We have reciprocal "mutual aid" transport agreements with most of our neighboring fire districts. If one of their medic units responds into our fire district and takes you to the emergency department, you receive the same "no out-of-pocket cost" ambulance service as if an East Pierce medic unit took you to the hospital. We reciprocate when we respond into their districts when they need mutual aid, as well.

What happens if a private ambulance takes me to the hospital?

In addition to our "mutual aid" responses • from other fire departments, private ambulances are used occasionally to transport district residents to the hospital. In this case, patients will receive a separate bill from the private ambulance company and are responsible for any portion not covered by insurance. There is no mechanism to use the EMS Levy fund to cover any of those costs. Additionally, private ambulances are frequently used by urgent care clinics and assisted living centers to transport patients to hospitals for follow-up medical care. In this case, payment for these calls, which are not part of the 911 system, would be the responsibility of the patient.

Does this agreement apply if I'm a district resident, but get hurt in some area outside the district, such as Puyallup or Spanaway?

The reciprocal "no out-ofpocket expense" mutual aid agreement only extends to 9-1-1 calls inside our own district. If you become ill or injured in a neighboring fire district, even if we have a mutual aid transport agreement, you will be responsible for the ambulance bill if they transport you to a hospital. There is no EMS levy "writeoff" provision when you are outside the district and become ill or injured. . ■

Bathroom Exhaust Fan Fire Hazards

Cause fires? Yes, definitely! In the first few months of 2022, EPFR crews responded to two residential structure fires started by bathroom exhaust fans.

Exhaust fans are found in almost all residences and many commercial properties to help prevent steamed-up mirrors, damp walls, fogged windows, and removing odors. However, they can also present a potential fire hazard if not cleaned and maintained regularly.

Lint accumulation varies depending on the frequency of use and the amount of particulate in the air. "Fans can overheat when clogged by lint, dirt, and dust, when left on too long, or because of simple failure. The lint provides an easy-to-ignite fuel source, which can quickly spread to the attic," says East Pierce Assistant Chief/

Fire Marshal Chuck King. "The buildup of lint and dust within the fan and on the motor can increase the potential for fire but can be easily removed to reduce the risk."

These fans are not designed to last forever, and many were installed when the houses or businesses were first built. As the fans age, the bearings wear out and may seize. Older exhaust fans are not thermally protected. Thermal protection causes the motor to shut off should it seize and overheat. Although this safety feature has been available since the late 1970s, it was not widely used until the early 1990s.

East Pierce offers a few safety tips to reduce fire risk and keep your ventilation fans running smoothly.

• All bathroom exhaust fans should be inspected and

cleaned twice a year. If it starts to make noises or smells odd, it's time to replace it. Pay careful attention to all air-flow areas.

- Fans that are old, appear to have heat damage, do not turn freely, or are not easily accessible to clean regularly should be replaced. New fans are thermally protected and will increase safety.
- Avoid prolonged use and turn it off before leaving home.
 Consider installing a timer switch instead of a manual switch to limit the unnecessary use of the fan.

Taking a few minutes a couple times a year to clean your exhaust fans and ensure they are running smoothly can help reduce fire risk and protect your families, homes, and businesses. ■

Cleaning a Bathroom Exhaust Fan

- 1. Turn off the power to the fan at the breaker box.
- 2. Remove the fan cover.
- 3. Clean the fan cover on both sides with your vacuum's brush attachment or wash thoroughly and let dry.
- Reach your vacuum's dusting attachment inside the space to clean the fan housing and motor. Use the crevice tool if areas are hard to reach.
- 5. Reinstall the fan cover onto the attachment clips and press it back into place against the ceiling.

Who Is East Pierce Fire & Rescue?

East Pierce Fire & Rescue was founded on a strong commitment to customer service. The district's *Mission, Vision and Values* guide the actions of the department and its employees. Exceptional customer service and concern for employees and their families have become hallmarks of our culture.

EPFR was created when the City of Bonney Lake Fire Department, Pierce County Fire District 22/Lake Tapps Fire and Pierce County Fire District 24 merged in 2000 with the goal of providing a seamless response to emergency situations.

Since then, the following mergers or annexations into EPFR have occurred:

- 2006: Pierce County Fire District 12 and South Prairie/Fire District 20
- 2008: Sumner/Fire District 1
- 2010: Edgewood/Fire District 8
- 2013: Milton Fire Department

Today, East Pierce serves a population of approximately 100,508 residents living in and around Bonney Lake, Sumner, Lake Tapps, the Ridge Communities, South Prairie, Tehaleh, Edgewood and Milton. The district covers approximately 153 square miles and protects residents from 8 stations - six staffed and one volunteer, and one facility on Lake Tapps for the marine rescue unit.

All full-time firefighters are crosstrained as either emergency medical technicians (EMTs) or paramedics and can respond to both medical emergencies and fires.

An independently-elected Board of Commissioners govern the agency.


